President's Message



Hi Everyone,

We had quite a celebration at our Annual Awards Night and Installation of Officers Ceremony at the Mystic Hilton on December 11. For those who could not attend, there's a listing of our 2009 award winners, 2010 board members and some great

pictures taken by photographer Craig Woody in our centerfold.

In spite of the challenges so many have been facing this year, the BAEC membership has rallied together and had a very productive year for the BAEC as a whole, its membership and our community! We began this year with a very successful Home and Better Living Show, showcasing member products and services.

With support from the National Housing Endowment we embarked on a Green Building for Consumers program, which centered on the BAEC 2009 Green Showcase Home by member Jim Pepitone of Ark Ventures. We took out paid advertisements, 100 radio announcements and issued numerous press releases about the home, the National Green Building Standard, and our members who had achieved the status of certified green building professional. We held a green expo on the site for BAEC members in June and on September 26 and 27 we held an open house for the public to benefit the American Lung Association's Breath Express. The open house was attended by consumers, our Killingly High School Student Chapter, and many local and association dignitaries, among them Michael Luzier, President & Chief Executive Officer, NAHB Research Center. The house achieved the 2nd NAHB Emerald Green rating in the nation, ALA's Health House designation, became the Department of Energy's Build America prototype Home, and, of course, earned Energy Star certification.

The second aspect of our program was to remodel our old web site and to build a special section on green building. It contains important links to building green information and to date; we've posted 7 You-Tube videos on green building by our showcase home builder. We have 13 additional videos on the editor's table as I write this. I'm pleased to say our web site is averaging about 500 unique visits each week! A social networking campaign in 2010 will allow us to broaden our audience and boost our website and our member websites on the Google ratings. I understand a Facebook page is in our future.

Reporters have learned to come to the BAEC staff, members and website as a premier source

of housing news and information for their stories, so be sure to link up!

We've entered into a partnership with Three Rivers Community College to offer construction industry educational classes. This allows us to outreach to over 2100 registered new home construction and remodeling companies in New London and Windham counties about the benefits of industry education and of becoming a member of BAEC.

We'll be offering Certified Green Professional Training in January, and Project Management and Advanced Green Building Sciences in February. We will be the first in the state with this offering, taught by John Barrows who assisted in developing the curriculum and delivered the pilot offering of this course in November.

Most recently we've been able to keep on top of the new EPA lead paint renovation requirements and booked one certification class in 2009 with three additional classes scheduled for January and March 2010 to ensure our members have access to training to meet these requirements.

We had a very successful golf outing in September which raised over \$10,000 for the L&M Hospital infant intensive care unit. We donated an additional \$1, 000 in support of members' charitable efforts.

We published a consumer membership directory, a member to member directory, and twelve issues of the Straight Edge and contributed to local papers, news stations and CT Builder Magazine.

We held monthly networking and educational meetings over the course of the year.

We participated in Building Industry Day at the Capital to inform legislators about the building industry.

We've offered our members numerous marketing and sponsorship opportunities, including a cooperative billboard advertising program in conjunction with the home show.



New! Locals & Legislator Meetings

The Government Affairs Committee of the HBACT has started a new program: **Locals & Legislators Meetings.** At last spring's Building Industry Day at the Capitol, members were able to set up meetings and establish relationships with 34 legislators. The Locals & Legislators Meetings will build on that effort by hosting small group meetings across the state where members and their legislators can meet informally over coffee and talk about issues.

Meetings have already been held in Ellington and Middletown, and more will be scheduled. When the dates and locations are set, HBACT will invite legislators from the area to attend. Members are invited to attend, **and** to contact their state representative or state senator to personally invite them to attend.

The HBACT Government Affairs issues list was used as the starting point for conversation at the first meetings, but over the 2-hour session, the discussions covered a wide range of topics. These meetings are an opportunity to get to know your legislators and tell them face-to-face how the decisions they make at the Capitol affect your business. Stay tuned for more information in coming months.

HBACT submits testimony on AD&C issues to the State Legislature's Banking and Commerce Committees

In August and September, HBACT set up meetings with U.S. Representatives Courtney, Himes and Larson to talk about the credit crunch and problems obtaining acquisition, development and construction (AD&C) loans. Now, **Senator Gary LeBeau**, cochairman of the state legislature's Commerce Committee and **Senator Bob Duff**, co-chairman of the legislature's Banking Committee have invited HBACT to testify in front of their committees on the ongoing credit crunch, appraisal problems and FHA pre-sale requirements. Bill Ethier, CEO of the HBACT, provided written testimony to the committee and shared an NAHB Survey on the credit crunch across the country. The testimony and NAHB survey are posted at www.hbact.org. Addi-

tional meetings between HBACT members and Commerce and Banks committee leaders will be planned.

Senate Begins Floor Debate on Health Care

The Senate last week began floor debate on health care reform bill H.R. 3590. The Congressional Budget Office estimates that the Senate package would cost \$849 billion over 10 years and would reduce the federal budget deficit by \$130 billion over the same period while expanding medical coverage to 94% of Americans.

The Senate plan contains several notable differences from the bill that was recently passed by the House by a narrow 220 to 215 margin.

The Senate legislation would impose a surtax on high-cost "Cadillac" insurance plans to help finance coverage of the uninsured, while the House bill seeks to raise revenue by charging a surtax on taxpayers with adjusted gross incomes of \$500,000 for single taxpayers and \$1 million for joint filers. The two chambers differ in terms of abortion restrictions and the scope of the public option.

The Senate bill is far less burdensome to small businesses than its House counterpart. The House bill contains a broad employer mandate that the Senate bill does not. However, the Senate package would levy financial penalties on most firms that fail to provide health coverage and also would require all individuals to carry health insurance.

As the Senate bill currently stands, it does not have the necessary 60 votes to move forward. As a result, a number of amendments will be offered and debate will continue in an effort to pass the legislation by the end of the year. Senators must compromise on issues such as the public option, abortion and immigration.

The following is a breakdown of key areas of the Senate health plan of interest to NAHB members:

Employer Responsibilities.

Those with more than 200 employees must automatically enroll all new workers in health care coverage. Employers with more than 50 employees must offer coverage to their employees.

Employers with more than 50 employees who do not offer coverage and have at least one employee receiving the premium assistance tax credit would be fined the lesser of \$750 multiplied by the number of employees or \$3,000 for each employee receiving a tax credit. Businesses with 50 employees or less would be exempt from this responsibility.

Employers with more than 50 employees would be required to pay a fine for implementing waiting periods for employees who want to enroll in coverage: \$400 per employee during a 30 to 60 day waiting period; \$600 for any employee during a waiting period exceeding 60 days.

Small Business Tax Credit. These firms would receive tax credits equal to 50% of the amount of health coverage they pay for each employee. The tax credit would be limited to businesses with 25 or fewer full-time employees and with average annual wages below \$40,000. The full credit would phase out for employers with more than 10 full-time employees or average annual wages.

Income Tax. The Senate bill would increase the hospital insurance payroll tax by .5% on individuals earning more than \$200,000 and couples earning over \$250,000, effective 2013.

Insurance Fees. The Senate plan would impose a 40% excise tax on employer-sponsored health coverage that exceeds \$8,500 for an individual and \$23,000 for families, effective 2013.

Obama Touting Home Energy Efficiency Program

Hoping to jump-start his plans for job growth, President Barack Obama is pushing Congress to pass incentives for homeowners who retrofit their homes to make them more energy-efficient.

Last week, the president proposed a new spending plan that would provide tax breaks for energy-efficient retrofits in homes. The plan also calls for small business tax cuts and new spending on highway and bridge construction. The administration hasn't put a price tag on the plan, but it could cost more than \$150 billion.

The White House hopes the appeal of the retrofitting program — which some administration officials have dubbed Cash for Caulkers — will be similar to the now-expired Cash for Clunkers program, which offered rebates for trading in used vehicles for more fuel-efficient ones. At a White House jobs summit earlier in the month, Obama told Home Depot chairman Frank Blake that home improvement companies would be key partners in this program.

Obama has also proposed expanding stimulus initiatives that promote energy efficiency and clean energy jobs. Currently, about \$8 billion of the \$787 billion stimulus package goes toward energy-saving investments in homes. The White House has said investments like installing insulation, sealing leaks and modernizing heating and air conditioning equipment will pay for themselves many times over.

In a memo for the president, Vice President Joe Biden said stimulus spending and other initiatives will lead to 1 million home energy-efficiency retrofits by 2012. The report also said the U.S. is on track to double renewable energy generation, including solar, wind and geothermal, in three years.
