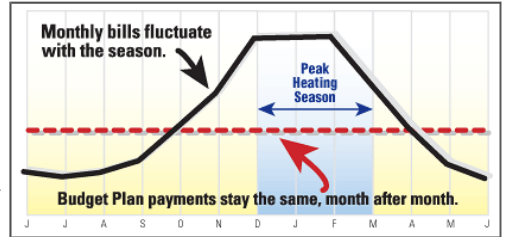

Smart Pay Budget & Capped Smart Pay Budget Terms & Conditions: Capped Smart Pay Budget Plans: Your first budget payment is non-refundable and will be used to purchase your capped protected gallons. Incorrect Gallons Used To Figure Monthly Payment: The homeowner is ultimately responsible for the oil consumed in their home and if the gallons used exceeds the budgeted amount the cap WILL NOT apply to the overage gallons and the customer will owe an additional amount. The customer may not exceed a balance that is greater than 3 budget payments. If a balance exceeds 3 budget payments the customer will be required to pay an increased amount prior to the next service or delivery. Smart Pay Budget Plans (un-capped): You will be billed the full price of the oil delivered and the cap price WILL NOT apply. At the conclusion of this budget period, the customer agrees to pay any outstanding balance. Past Due Accounts: Failure to maintain your account in good standing will result in early termination from the budget plan. Early Termination/Liquidation Fee: If you terminate your budget plan in less than 12 months, you agree to pay an early termination and liquidation fee of \$150. Home Sales or Assignment: Upon the sale of a home, our customer may request a refund in writing to Benvenuti Oil. There is a \$50 administration fee deducted from the refund check. Automatic Oil Delivery: We require all our budget customers to be on automatic oil delivery & the customer agrees to receive all their oil from Benvenuti Oil. Upon the completion of the oil contract we will continue to deliver your oil automatically to ensure you don't run out which could cause home damage resulting in additional bills. If after 12 months from signing you wish to be removed from automatic delivery, please notify us in writing. Will Call Oil & Minimum Delivery: If a customer requests to call for each delivery (will call) there is a 150 gallon minimum delivery & if a customer fails to receive at least 100 gallons a \$50 charge will be billed to their account. Force Majeure: Duty to Perform: Benvenuti Oil Company, Inc or related parties will not be liable for any breach, delay or nonperformance hereunder which results from, in whole or in part, civil commotion, labor unrest, strike, war, fire, storms, embargoes, or other restrictions imposed by law, floods, other acts of God, or other impairment with the seller's supplier(s). Businesses and Non-Residential Customers: If the oil is used primarily for non-residential heating you are required to pay State of Connecticut Sales tax on your oil. Please add 6% to the total cost.
