Recap of 2018 Annual Conference June 24-27, Atlanta, Georgia

The Annual Conference had great sessions and a key note speaker this year. In addition to the traditional format of sessions, they added a few new fun activities. Each morning you could join in a group walk or do yoga to get your day started. They had a city scavenger hunt where you needed to find different places in the city and do a selfie that you were there, giving you a great chance to see what Atlanta had to offer. I participated in the first sew in quilt competition. It was quite fun, there were two teams we worked on making a jellyroll quilt top. I am happy to say, that the team I was on won.

The key note that really made me think was Dr. Deana Simmons with her talk about *The Emotional, Intellectual and Culturally Responsive Practices* for thriving families and youth. She said, we must teach children to love themselves because of the media, a lot of people have "*Imposter Sydrome*", in which people have a great fear of being exposed and a lot of anxiety of what will happen if this were discovered. They are often code switch talking one way here, but back home another way.

During the conference Dr. Jody Roubanis, CFCS proposed that we as a national organization for the family to take a stand to <u>Support Humane Policies & Treatment of Families Crossing Borders into the United States</u>. She wrote this resolution with several people from the Global Perspecitves Committee. After revisions, this has been accepted by AAFCS. You can go to the aafcs.org website and read.

Our National organization, AAFCS, has taken a stand on individuals and families involved in the USA border crossing issue. The Atlanta June Conference & Expo saw a revised position paper on "Keeping Families Together" brought forward by the Global Perspective Community." This rewrite of the 2018 resolution builds on the 2015 resolution concerning minors at the border. Jody Roubanis, CFCS, and a California resident spearheaded the resolution and paper. The writers involved with the paper include member leaders in the above community: Janie Leach, Shawnee Hendershot, Brownyn Fees, Chantelle Eggleton, and Lorn Wound. A clear definition resulted illustrating National's support for the cause to keep immigrant families together. **This is an exemplary issue of our mission statement:**

To provide leadership and support for professionals whose work assists individuals, families, and communities in making informed decisions about their well-being, relationships, and resources to achieve optimal quality of life.

Of course, many professional groups have made their case as well in the need to support the person regardless of nationality of origin. How many of us as professionals and community members have <u>not</u> been introduced to a person or family who has migrated within let us say the last ten years to this country? My guess would be none of us. We know that all of us got our start from an early generation of parents who came from another country to the United States. We need to applaud those who have come forward to support and aid refugees and the status they have in a free country.

In sum, the federal efforts made in the name of safety & security have failed and failed miserably. In effect, safety is now a risky proposition for those seeing crossing the border as their only option for a safe living environment. The family unit is not one to break apart but one to make secure, protect and support. Maslow's Hierarchy of Needs clearly puts safety at the wide base of the pyramid because it is what holds up the individual and makes a secure base on which to build the "total" person.

Services such as identity theft protection, insurances, and legal services are just a few of these additional perks. A noteworthy benefit is the networking one can do within the organization. 
Chloe Kubin 2018 Student Scholarship Recipient



Fall Policy & Legislation Submitted By Judy Hinman, chair

Federal Level

• Perkins Act now has \$1.2 billion until 2023. Trump officially signed H. R. 2353 on July 31. "Strengthening Career and Technical Education for the 21 century Act" states that FCS has local use of funds. State Level

• Active teachers had an increase of 1% added to the pension contribution. The total 7% contribution is being used to help reduce the state's unfunded pension liability. ARTC {Assoc. of Retired Teachers} has a goal to repeal the unfair federal law called US Government Pension Offset and Windfall Elimination Provision {GPO/WEP}. The health insurance fund for retired teachers has been temporarily fixed by switching coverage to Medicare Advantage. Retired teachers need to be enrolled in Medicare to participate in this supplemental plan. The state kept the 25% income tax exclusion on pensions; no indication when the postponed 50% exclusion will become effective. {This is termed "fair" because teachers do not have Social Security. If teachers contributed to SS by doing employment outside of public education and have 40 quarters or have a spouse of 10 years, you qualify for Medicare.}



National AAFCS

- There is a demand for FCS educators in secondary schools, higher education and Extension. The "Say YES to FCS" project is to create resources to support FCS educator recruitment, promote FCS careers and to share resources at the national level. A total grant of \$936,572 was awarded from USDA that included matched funds from AAFCS, FCCLA and SUNY Oneonta. Each affiliate should have a State Action Team to help move "Say YES to FCS" forward. - "Financial Fitness" was year 2 goal of "FCSfit" and theme for the national conference and CT/AAFCS spring meeting at the Norwich Inn & Spa. Year 3 of the "FCSfit" Initiative is themed "Emotional Health & Relationship Well-being". Can your curricula be adapted somehow to include this theme?
- At the 109th conference & Expo in June there was a proposal "Support Human Policies & Treatment of Families Crossing Borders into the United States". It was initiated by the AAFCS Global Perspective Community and supported by the AAFCS Public Policy and the Family Relations & Human Development Communities. The Board of Directors approved it on July 9, 2018. Go to aafcs.org, resolution tab for details.
- The 110th AAFCS Conference & Expo will be held in St Louis, MO on June 23 to 26, 2019; too soon for details.
- AAFCS Fall Webinar schedule begins Sept. 27 with Creating Competent Global Classrooms. This is followed by 2 webinars each month in Oct., Nov. and Dec. A few of the other themes are Grief at School, Device-Free Dinners, FCS Framework & Career Clusters. These are FREE for members. For details and registration for the webinars, visit aafcs.org
