TOWN OF LISBON ANNUAL TOWN MEETING

To the electors and those qualified to vote at the Annual Town Meeting, warning is hereby given that the Annual Town Meeting of the Town of Lisbon will be held on Monday, May 2, 2016, at 7:00 p.m. in the Lisbon Central School Cafeteria/Gymnasium, 15 Newent Road, Lisbon, Connecticut for the following:

- 1. To discuss the General Government Budget, for Fiscal Year 2016/2017, as approved by the Board of Finance, in the amount of \$2,709,831.
- ·2. To discuss the Board of Education Budget, for Fiscal Year 2016/2017, as approved by the Board of Finance, in the amount of \$9,483,998.
- 3. To authorize the Board of Selectmen as approved by the Board of Finance, to expend \$414,616.00 for the repair of the bridge on Bundy Hill Road over Blissville Brook, with \$216,222.00 from the Town Aid Road (TAR) fund and \$198,934.00 from the General Fund, which will be reimbursed through a grant from the State of Connecticut Department of Transportation Local Bridge Program.
- 4. To authorize the Board of Finance, the transfer of \$190,000 from the General Fund, to the Capitol Reserve and Nonrecurring Fund.
- 5. To adjourn the Annual Town Meeting action upon the General Government Budget and Board of Education Budget, pursuant to "An Ordinance Requiring Referendum Votes for the Annual Town Budget," for a referendum vote on Monday, May 16, 2016, between the hours of 6:00 a.m. and 8:00 p.m., to be held in District 1 at the Lisbon Town Hall, 1 Newent Road, and in District 2 at the Lisbon Senior Center, 11 Newent Road, Lisbon, Connecticut 06351.

A copy of the Fiscal Year 2016/2017 General Government Budget, Board of Education Budget and Bundy Hill Road bridge project documents are available in the office of the Town Clerk, Town of Lisbon, 1 Newent Road, Lisbon, Connecticut 06351, during normal business hours.
