TOWN OF LISBON ANNUAL TOWN MEETING

To the electors and those qualified to vote at the Annual Town Meeting, warning is hereby given that the Annual Town Meeting of the Town of Lisbon will be held on Monday, May 5, 2014, at 7:00 p.m. in the Lisbon Central School Cafeteria/Gymnasium, 15 Newent Road, Lisbon, Connecticut for the following:

- 1. To discuss the General Government Budget, for Fiscal Year 2014/2015, as approved by the Board of Finance, in the amount of \$2,545,963.
- 2. To discuss the Board of Education Budget, for Fiscal Year 2014/2015, as approved by the Board of Finance, in the amount of \$9,541,378.
- 3. To discuss and act upon the Town Aid Road Fund, for Fiscal Year 2014/2015, in the amount of \$88,038.
- 4. To authorize the Board of Finance, the transfer of \$190,000 from the General Fund, to the Capitol Reserve and Nonrecurring Fund.
- 5. To authorize the Town of Lisbon acting through the Board of Selectmen, to offer for sale and/or dispose of any damaged, outdated or non-repairable property from the fixed asset inventory.
- 6. To authorize the Town of Lisbon, acting through the Board of Selectmen, as approved by the Planning and Zoning Commission to accept and record the Declaration and Grant of Conservation Easement in favor of the Town of Lisbon with respect to the Barber Farm subdivision located at the southwesterly intersection of Mell Road and River Road in Lisbon, Connecticut.
- 7. To authorize the Town of Lisbon, acting through the Board of Selectmen, as approved by the Planning and Zoning Commission to accept and record the Conservation Easement Agreement in favor of the Town of Lisbon signed by Phillip C. Armetta on behalf of the property owner, Lisbon Industrial Park, L.P.
- 8. To adjourn the Annual Town Meeting action upon the General Government Budget and Board of Education Budget, pursuant to "An Ordinance Requiring Referendum Votes for the Annual Town Budget," for a referendum vote on

Monday, May 19, 2014 between the hours of 6:00 a.m. and 8:00 p.m., to be held in District 1 at the Lisbon Town Hall, 1 Newent Road, and in District 2 at the Lisbon Senior Center, 11 Newent Road, Lisbon, Connecticut 06351.

A copy of the Fiscal Year 2014/2015 General Government Budget, Board of Education Budget, as well as the Lisbon Industrial Park, L.P. Conservation Easement and Barber Farm subdivision Declaration and Grant of Conservation Easement are available in the office of the Town Clerk, Town of Lisbon, 1 Newent Road, Lisbon, Connecticut 06351, during normal business hours.
