Mr. Sparkman advised that the board has received the projected budget worksheet and site civil proposal. He noted that the project is still before the Board of Finance.

i. Town-Wide Recycling

After discussing the recommendation of the town's Recycling Coordinator, Winston Averill, W. Surfus moved to approve "option one" and agree to the biweekly manual curbside collection; the town will continue to own the bins, with Willimantic Waste agreeing to supplement additional bins to accommodate the change in the collection schedule. We agree to change the collection geography by dividing the tow in half with Willimantic Waste providing a collection map prior to final approval of the agreement, and leave current service in place until the beginning of Fiscal Year 2018/19 (July 1, 2018) at which time we agree to a five (5) year contract at \$53,000 per year for the first two (2) years with a 3% increase in the final three (3) years. Willimantic waste will work directly with the Town of Lisbon to notify the residents of the change in their recycling service. Willimantic Waste will continue with the current agreement with the Town of Lisbon for use by the residents of the Rhoode Road Transfer Station with no reduction in the scope of the services provided for five years at the cost beginning July 1, 2018 of \$9,500 per year for the first three (3) years with a 3% increase in the final two (2) years.
