f. Board of Finance – Purchasing Ordinance

Mr. Sparkman reported receipt of a revised proposed purchasing ordinance document, which he advised was distributed to all cost centers for review and comment.

g. Public Act 17-65

Mr. Sparkman noted copies of emails, in the Selectmen's packets, regarding discussions between the Chairman of the Board of Finance and the Assessor regarding tax revenues.

h. Lisbon Fire Department

Mr. Sparkman reported that the Board of Finance discussions regarding bonding are ongoing. He advised that with the August due date for the pay down on debt service it will be impossible to include the existing bond anticipation notes into the fire department bonding.

i. Wheelabrator Lisbon

Mr. Sparkman advised that discussions regarding the Host Town Agreement between the town and the Eastern Connecticut Resource Authority have begun. He further advised that Attorney Olsen, Murtha Cullina, LLP Town Counsel, has hired David S. Brown who has forty years of experience and expertise in the evaluation, development, implementation and management of solid waste and related projects as a consultant to assist with the negotiations.

j. Tunnel Hill Road - Culvert Repair

Mr. Sparkman reported that the culvert repair project began on June 4th and is expected to take about three weeks to complete.

k. Request, Lisbon Historical Society – Neighborhood Assistance Act Program Mr. Sparkman advised that the Historical Society is completing the application with their consultant which will come back to the town for submission.
