The new pumps would have stainless steel fittings which last longer than the current brass fittings. Motion made by D. Other business- NPU would like to install a permanent tripod/winch over the wet wells to remove pumps to be worked on. This would save having a second and third truck brought in by NPU to complete work on the pumps. J. Lewerk motioned to have NPU install the tripod/winch, not to exceed \$3000.00, seconded by K. Robb
