A. NPU is recommending that the two pumps in the pump station be tied together and then tied into the control board at NPU. This would allow NPU to run the second pump simultaneously to avoid one pump being overcome by too much flow. The second pump would be turned on to take the overflow. The cost of the work, labor and materials, would not exceed \$900.00. J. Lewerk motioned to approve NPU to rewire pumps to run simultaneously when needed and tie into NPU's control room.
