Greens Dan Rodgers

When is it time to close the greens for the season? Every course is unique in its location, weather conditions, soil type, budget and membership. The most common reason for closing the greens is the weather. Before the ground starts to freeze and thaw, closing of the greens must be considered. Late season play on the greens can injure turfgrass because leaf tissue has stopped growing. Turfgrass crowns, where both roots and shoots are generated from, can be permanently damaged if golfers are allowed to play on frozen or freezing and thawing greens.

The "freeze & thaw" period can actually be the most damaging time. If underlying soil is frozen and the immediate surface is not, traffic will actually shear the roots off. The soil movement on the thawed surface causes detachment from the root system, which is stuck in the frozen soil beneath.

It is difficult to decide when the timing is right. We need to be able to accurately forecast the weather well in advance. Ultimately, we want members to enjoy the course as long as possible but not at their own expense. It's much worse to close the greens too late to satisfy the minority and have the majority suffer the consequences next season.

My number one goal is to protect the greens for the players next season. Every agronomic decision and maintenance practice we utilize from September to June is a preparation for next year's peak playing season. The greens must enter the stresses of summer with the healthiest turf possible to give them the best chance of survival and provide our members with the conditions they deserve.
