It has been eight months since my last written report and we have accomplished much, but still have numerous challenges in front of us. The finance committee has met approximately 7 times since the last report. Isaak Lazerou and other members of the committee continue to tackle specific issues, which we had identified earlier in the year and others that have surfaced. We have attempted to be *proactive* in identifying both short and long term issues, *transparent* in communicating to the membership, *supportive* in working with our managers/staff, and *financially responsible/trustworthy* in handling the member's funds.

The number #1 priority (a 2.125% mortgage interest rate reduction) from my first report has been in effect since March 1st. Next year's budget will reflect the full twelve months (\$90,907) of that cash flow savings. Since then, representatives of Dime Bank have been our guests playing golf at NLCC with George Mitchell and myself, and have discussed the club's additional desire to eliminate/defer the monthly principal portion of our debt service in the next 3 years, thru several mechanisms. This is another attempt at improving our cash flow for the foreseeable future (3 years). They have been very receptive to our desire to restructure the debt.

I must continue to restate the importance of selling our real estate lots. It is the **number #2 priority** as of now. Dime Bank is very willing to work with us and may allow some arrangement whereby we would be able to offset some portion of the monthly principal or use a portion to replace golf carts, which may need replacement to some extent next year. This option was envisioned by myself during the last budget deliberations as a possible alternative to any immediate minor cash flow shortage/member assessment. The consequence is obvious. The possible sales now appears to be at least a minimum of six months away.

The **number #1 priority** now is to form/fund an entity for the purpose of securing a 2nd mortgage financing in the amount of \$500,000, to be applied to the first mortgage balance. This task is time consuming and requires someone other than myself to take charge. The other individuals on that committee presently are George Mitchell and Kevin O'Reilly. This task could result in approximately \$150,000 of *cash flow savings* for each of the next 3 years. Anyone interested in being part of that LLC at an initial loan/contribution of \$50,000 should contact one of the committee members.

Item #4 in the first report (Cloud Nine, LLC issues) has been resolved and all financial consequences are reflected in the 2009 calendar results. This was a very messy situation and required considerable time to mitigate. Hopefully, future boards can learn a lesson from that experience.

The 2009 trial balance has been finalized and the corporate tax returns have been filed. The financial statements have been prepared and are located in the office as of November 1, 2010. The December 31, 2009 balance sheet has been cleaned up *(corrected/adjusted)* to remove receivables (members \$17,000 and Cloud Nine \$22,000), set up a food/beverage inventory, correct accounts payable, and adjust Cloud Nine payable.

The general ledger account structure has been modified in 2010. Additional changes are still needed and will be an integral part of the 2011 budget process.

The monthly September 30, 2010 internal financial reports have been modified by myself to more clearly communicate the financial data which I believe is most relevant. I included an adjustment in these statements to reflect the \$9,150 of chemicals which Dan Rogers has obtained (for 2011) in place of the defective chemicals paid for in 2010. Although the financial statements still appear to support sufficient cash to pay the December and January debt service, the level of payroll and operating expenses must be closely monitored.

Isaak and I are in the process of preparing a *projected* (thru 12-31-10) revenue and expense report (to be available at the annual meeting on November 4, 2010). This report will be our basis for making any financial decisions, which may be necessary over the next 2 months, to successfully transition into 2011. Isaak also is gathering 2011 budget data so that we might have a *draft* available for the annual meeting.

Another major task (short and long term consequences-**priority #3**) is the reduction of our property tax expense. We will be paying approximately \$80,000 for the 12 months ended June 30, 2011. I project that expense to increase 10% each year thereafter. It will become the largest expenditure, other than debt service and payroll, in our annual budget. The club is basically an "open space" entity, providing charitable fund-raising on a large scale, providing our golf facility to local secondary schools at a very small fee, requiring almost no education, fire or other community financial support, yet we are taxed as if our real estate is basic residential real estate taxed the same as any other residential property. We must and will appeal our assessment. We are a non-profit entity and need to reinforce this with Town officials.

I have received Excel spreadsheets for the years 2006-2009 showing the balance sheet and income statement from Ed Lorah's firm. I will attempt to present those 4 years of data together with our 2010 projection in a *five year comparative format* for the annual meeting.
