Legislative Meeting at The Arc

As you may be aware, Governor Dannel P. Malloy recently ordered more than \$65 million in state budget cuts. These cuts have been spread among more than 40 departments and agencies, but the Department of Developmental Services certainly took the biggest hit at \$17 million dollars. People with intellectual and developmental disabilities did not cause the deficit, however, it appears as though they will be paying the price for it. This directly affects The Arc Quinebaug Valley, and all similar agencies in the community.

DDS Commissioner Morna Murray had announced that due to the magnitude of Governor Malloy's proposed cuts, 2016 would be the first year DDS could not guarantee there would be any services for new graduates and age-outs. This meant that in addition to a growing residential waiting list of more than 2,000 people, we would also now have a Day and Employment waiting list. Graduates should be able to look forward and start a new chapter in their lives by using their hard earned skills, but instead graduates would have languished at home, until legislators rejected the Governor's proposals and fund DDS services. Knowing how important it is to make all of our voices heard, The Arc Quinebaug Valley hosted a Legislative Meeting at our agency on the night of March 28th.


Over 60 people were in attendance, including State Representative Mike Alberts, State Representative Daniel Rovero, State Representative Christine Randall, Shannon Jacovino from The Arc CT, Arc Administrators, Arc Board Members, Arc employees, families who are and will be directly affected by these cuts, and community members.

Parents of individuals with disabilities in the community stood up and spoke directly to the legislators about their hardships with the already under-funded DDS system. Tears were shed due to the fear and severity of these proposed budget cuts, but there was still a sense of hope in the air that the legislators could help stop these budget cuts from happening.

Legislators voted on an alternative to Governor Malloy's plan on March 29th, the very next day after our Legislative Meeting. The deficit mitigation plan resulted in a cut of \$3,393,681 from the DDS budget, however Day Services & Employment funding was spared. Hard works pays off, and although there is still a cut occurring, our voices were definitely heard, and we will stand together and continue to be heard.

Thank you to all who attended this meeting, helped make this meeting possible, or supported The Arc with regards to this meeting.

Sunburst Smoothie


Here's what you'll need:

Self Advocacy Talk

A Word From Our Self-Advocate Coordinator:

The Self-Advocacy Group is changing to a more educational group that links back to self-advocacy and the group members' lives. We have developed our own steps to being an effective Self Advocate, which include: believing in yourself, having a goal, making a plan, gathering resources, accepting differences, avenues to advocate, taking chances, making your voice count and re-evaluating your goal.



In the first two months of the year, we had a group activity involving having a goal. We also had a speaker, Ann Tetreault, come in to talk about making a plan and who to ask for help on your journey. At our May 25th meeting we will have Representative Danny Rovero come and speak about his job as a state Representative in Hartford. We will also ask him questions about the state budget.

I continue to fight in Hartford, reminding legislators and the Governor's office that all "people matter", and convey the importance of fully funding the DDS residential waiting list, as well as supporting recent High School graduates and students who will age out at 21. The fight will not be over until people with intellectual, developmental and other life affecting disabilities are included in all aspects of society. I would like to paraphrase State Senator Ted Kennedy Jr., "We are advocating for civil rights, equality, self-determination and dignity for all citizens of this great state."
