Legislative Meeting

April 4th marked a very important night at The Arc Quinebaug Valley. A legislative meeting was held at our Cook Hill Office location from 6:30 p.m.—8:00 p.m. to discuss important items concerning the crisis in Department of Developmental Services (DDS) supports. Families whose children and loved ones rely on DDS services now or who will need them in the future have much to be anxious about, therefore, The Arc wanted to provide an outlet for people to voice their opinion to our local legislators.

Legislators in attendance were State Representative Anne Dauphinais, State Representative Daniel Rovero, State Representative Pat Boyd and State Representative Doug Dubitsky. Arc Board Members, Arc staff, Arc individuals and their families were also present, many of whom shared their frustrations with the state budget in regards to nonprofit human service agencies. It is always important to realize the stance that our legislators have on specific topics. The more information that legislators have, the more informed they are when making decisions.

Shannon Jacovino with The Arc Connecticut stood before everyone and provided a brief overview of budget happenings and ways in which families can be proactive. Other topics raised at this meeting included the need to restore funding for Day & Employment Services for new graduates, restore funding for Family Support Grants and for new families who need Behavioral Support Services, overtime costs and waste in DDS, and long-term budget savings for the state by using community services.

Although we are continuously faced with budget cuts, we will never give up on the individuals we serve. We will continue to speak to our local legislators about our concerns and help to promote positive changes within the state budget regarding non-profit service agencies. Community based supports can be provided to individuals for lower cost than that of state agencies. Not only do non-profits help to save the state money, but we provide the same exact services and a very high quality of care right in your own hometown! The Arc may encompass a little portion of Connecticut, but our hearts are big and our dedication to our individuals is strong! It was evident from this Legislative Meeting that the legislators are on our side, and we couldn't be more proud that our advocacy is working!














In the Spotlight


Staying Healthy & Motivated!

From Our Kitchen To Yours


Iomato Cucumber Avocado Salad

Ingredients:

- 1 large avocado, peeled, seeded chopped
- 1 tsp. lemon juice
- 2 cups cherry tomatoes, halved
- 2 cups yellow cherry tomatoes, halved
- 1-2 english cucumbers, peeled and chopped
- 1/4 cup chopped red onion
- 4 oz. feta cheese crumbles
- 1 Tbsp. red wine vinegar
- 2 Tbsp. olive oil
- salt and pepper, to taste
- 1/4 cup fresh chopped parsley

Directions:

Drizzle lemon juice over chopped avocado. Place avocado, tomatoes, cucumbers, onion and feta cheese in a large bowl. Whisk together red wine vinegar, olive oil and salt and pepper. Pour over salad. Top with fresh parsley. Toss gently to combine.

Self Advocacy Talk

A Word From Our Self-Advocate Coordinator:

Spring is very busy for your Self Advocate Coordinator. It's state budget season. There are about 35,000 bills in the legislature this session, and about 30 that can affect people (and their families) with intellectual, developmental and other life –affecting disabilities that I am personally tracking and submitting testimony on. I receive most of my information from DDS itself and its legislative affairs department, as part of the council on Developmental Services and the CT Cross Disability Lifespan Alliance.

Our two Self Advocacy Groups are moving beyond our "10 Steps to Being an Effective Self Advocate." We have more similar monthly topics for each group. Our latest topic has been "How to speak up at your IP meetings."

Our evening group has also been raising money for transportation to our People First Conference in June, in Meriden. We have been doing this by selling Yankee Candle products. My long term goal is to raise money to take a tour of the Capital in Hartford with our groups.

Winning hearts and minds is not easy but it must be done to promote equality for all citizens of this world.
